Huge Grants Announcement

Hope Haven is thrilled to announce that we have received two <u>major</u> multi-year grants totaling more than \$700,000 to support our work.

The first, a grant of \$500,000 from the National Institutes of Health (NIH) for a partnership between Hope Haven (HH) and the Medical University of South Carolina (MUSC), will fund a project that treats and evaluates adolescent victims of sexual abuse and assault. Teenagers who have experienced sexual trauma, are at increased risk for substance abuse, mental illness, school dropout, teen pregnancy and crime. The NIH grant will allow HH to give critical, life-changing services to nearly 600 adolescents over four years.

The second grant of \$216,000 from the Children's Trust of South Carolina will fund the implementation of Strengthening Families Program, an internationally recognized parenting program for families with children aged 6-11. Designed to provide families with concrete parenting support, the program is proven to reduce child abuse and neglect through training on parenting and family life skills.

The program is proven to reduce problem behaviors, delinquency, alcohol and drug abuse in children, while improving social competencies and school performance. The 100 local families (with 250 children) participating over three years will develop a safe and strong family.

"This is huge and hopeful news for families in South Carolina and is the result of an enormous amount of hard work by our staff and volunteers," said HH Executive Director Shauw Chin Capps. "This funding will allow us to greatly expand our reach as we work to strengthen our community through healing the trauma of abuse, violence and neglect and promoting safe, healthy and stable families through research based services.



It is hard to believe that August 13, 2013 marks my 10th year anniversary as executive director of Hope Haven. Time flies when you're having fun!

I am truly humbled and honored to have served this amazing organization over the past 10 years. This mile marker gives me an opportunity to look back at all the positive growth

When I first walked into Hope Haven's office in 2003, there were three staff members trying to provide services to five counties. Our budget was about \$220,000. Today our budget is \$950,000! Our staff has grown from three to 14 full-time and two part-time. Over the last 10 years, Hope Haven has served close to 4,000 direct victims of child abuse and sexual violence and more than 5,000 secondary victims. Those numbers are overwhelming, but in many ways, it is hopeful to see the impact one organization can have on the lives of so many victims and their loved ones.

Our work continues and the demand for our services grows each year as more victims need to find healing. We are proud of our growth because it means we can meet the needs of more victims. We are proud to continue the trend of implementing the evidence/research based programs that ensure our clients are receiving the best treatment possible.

As you flip through the pages of this newsletter, I hope you sense the joy and pride of being an integral part of the growth of Hope Haven. YOU, our loyal supporters, have made this growth possible. YOU have given the gift of hope and healing to so many.

Changing the Culture of Violence

The Men of Strength (MOST) Clubs have started a new school year! At this time, we have ten clubs at seven different schools in Beaufort and Jasper Counties including Ridgeland Hardeeville High School, Hardeeville Ridgeland Middle School, Lady's Island Middle School, Whale Branch Middle School, Whale Branch Early College High School, Beaufort High School, and Battery Creek High School. The Men of Strength (MOST) Club is a best practice violence prevention program for mobilizing young men to prevent sexual violence, dating violence, and bullying.





Hope Haven is implementing the Girls Circle program at Whale Branch Middle School and Lady's Island Middle School! Girls Circle is a structured support group for girls designed to build self-esteem and healthy relationships with peers, counter trends toward self-doubt, and allow for genuine self-expression through discussion and creative activities. Girls Circle members will hold discussions and activities based on topics such as sexual abuse, dating violence, human trafficking, and bullying.
